<u>c)</u>	I agree to pay \$26.00 per month in SNAP benefits from my January 2020 or(starting month) benefit issuance through my December 2020 issuance for a <i>Quabbin Harvest Deluxe Biweekly Fruit CSA Share</i> (average of 6-7 pounds of produce <u>every other week</u>).

<u>e)</u>	I agree to pay \$in SNAP benefits per month from my January 2020 or(starting month) benefit issuance through my December 2020 issuance as a partial payment towards the total monthly cost of my Quabbin Harvest Vegetable CSA Weekly Share (\$78.00 per month). I will pay the remaining balance \$ to Quabbin Harvest with a check or money order.
<u>f)</u>	I agree to pay \$in SNAP benefits per month from my January 2020 or(starting month) benefit issuance through my December 2020 issuance as a partial payment towards the total monthly cost of my Quabbin Harvest Deluxe Biweekly Fruit CSA Share (\$26.00 per month). I will pay the remaining balance \$ to Quabbin Harvest with a check or money order.
